NABERSNZ is a scheme designed to measure and rate the energy performance of commercial office buildings in New Zealand. An independent NABERSNZ Certified Rating compares a building's energy usage to other commercial properties.

Certified Ratings range from 0 to 6 stars with buildings scoring a higher rating demonstrating greater energy efficiency.

We can also provide an unofficial rating quickly as an initial start point for further discussions. Only a NABERSNZ Accredited Assessor can provide a formal rating.
